Obamacare Fix & Repeal Votes
114th Congress



H.R. 22, the Hire More Heroes Act (Rep. Rodney Davis) – Passed 412-0 **January 6, 2015** | Excludes employees who receive healthcare through the Department of Veterans Affairs or TRICARE from an employer's full-time employee count for purposes of the employer mandate. [Note: The Hire More Heroes Act was incorporated into P.L. 114-41]

H.R. 30, the Save American Workers Act of 2015 (Rep. Todd Young) – Passed 252-172 **January 8, 2015** | Amends the ACA's definition of full-time employees to those who work, on average, at least 40 hours a week.

H.R. 33, the Protecting Volunteer Firefighters and Emergency Responders Act (Rep. Lou Barletta) – Passed 401-0 **January 12, 2015** | Excludes the hours worked by volunteer firefighters and emergency medical responders from being counted toward the ACA's 30-hour-a-week benchmark that determines whether an employee is classified as full-time.

H.R. 596, to repeal the Affordable Care Act (Rep. Bradley Byrne) – Passed 239-186 **February 3, 2015** | Repeals the ACA in its entirety and restores the provisions of law amended or repealed by the ACA.

H.R. 1191, the Protecting Volunteer Firefighters and Emergency Responders Act (Rep. Lou Barletta) – Passed 415-0 **March 17, 2015** | Identical to language previously considered by the House that was included in H.R. 33.

H.Con.Res. 27, Establishing the budget for the United States Government for fiscal year 2016 and setting forth appropriate budgetary levels for fiscal years 2017 through 2025 (Rep. Tom Price) – Passed 228-199 **March 25, 2015** | Repeals the ACA in full, including all of its taxes, regulations, and mandates.

H.R. 160, the Protect Medical Innovation Act of 2015 (Rep. Erik Paulsen) – Passed 280-140 **June 18, 2015** | Repeals the ACA's 2.3% excise tax on medical devices.

H.R. 1190, the Protecting Seniors' Access to Medicare Act of 2015 (Rep. Phil Roe) – Passed 244-154 **June 23, 2015** | Repeals the authority and appropriations for the Independent Payment Advisory Board.

H.J.Res. 61, the Hire More Heroes Act of 2015 (Rep. Rodney Davis) – Passed by voice vote **July 27, 2015** | Identical to language previously considered by the House that was included in H.R. 22. [Note: The Hire More Heroes Act was incorporated into P.L. 114-41]

H.R. 3236, the Surface Transportation and Veterans Health Care Choice Improvement Act of 2015 (Rep. Bill Shuster) – Passed 385-34-1 **July 29, 2015** | Signed into law | Incorporated the Hire More Heroes Act into the underlying legislation.

H.R. 1624, the Protecting Affordable Coverage for Employees Act (Rep. Brett Guthrie) – Passed by voice vote **September 28, 2015** | Signed into law | Amends the ACA's definition of small employer to mean employers with up to 100 employees, instead of 50.

H.R. 2061, the Equitable Access to Care and Health Act (Rep. Rodney Davis) – Passed by voice vote **September 28, 2015** | Expands the religious exemption in the ACA by exempting any individual who is a member of a religious sect or division, who relies solely on a religious method of healing, and for whom accepting medical health services would be inconsistent with his or her religious beliefs from the law's insurance mandate.

Amendment to H.R. 1314, the Bipartisan Budget Act of 2015– Passed 266-167 **October 28, 2015** | Signed into law | Includes a provision to repeal the ACA requirement that employers with more than 200 employees automatically enroll new full-time employees in health insurance and continue coverage for current employees.

Amendment to H.R. 2029, the Consolidated Appropriations Act of 2016 (Rep. Charlie Dent) – Passed 316-113 **December 18, 2015** | Signed into law | Includes a two-year delay of the Cadillac tax, a one-year moratorium on the ACA's annual fee on certain health insurance providers, and a two-year moratorium on the ACA's medical device excise tax.

H.R. 3762, the Restoring Americans' Healthcare Freedom Reconciliation Act (Rep. Tom Price) – Passed 240-189 **October 23, 2015** | Repeals certain provisions in the ACA and places a one year freeze on certain funding for abortion providers such as Planned Parenthood.
